Construction of Ste Marie Bridge on B9 Road at Baie Jacotet Procurement Reference: W/RDA/34/03-18

1. Scope of Works

- a) Demolition of the existing structure and reconstruction of a reinforced concrete bridge/culvert approximately 55m span to provide unrestricted flow of the river into the sea. Provision of culverts /bridge, deck, headworks, footpath, handrails, lighting etc. The reconstruction of the bridge shall be undertaken as design and build basis by the Contractor;
- b) Upgrading and tie in of approximately 350m of B9 road on both sides of the new bridge;
- c) Upgrading and extension of existing drainage structure along existing road;
- d) Construction of road side footpaths, drains and retaining structures such as masonry walls;
- e) Diversion and relocation of existing services;
- f) Provision of miscellaneous road equipment such as road marking, cat's eyes, traffic signs, handrails, safety fences, road lighting etc...;
- g) Construction of one bus lay-by along B9 Road; and
- h) Any other works as detailed in the bid documents.
