

# **Executive Summary of Bid Evaluation Report**

## **1. Scope of work**

The current expansion of the SSR International Airport is anticipated to generate high volume traffic in the vicinity of the airport and Plaine Magnien Village. The solution proposed to mitigate the problem of traffic is to construct a 4.5Km long dual carriageway and associated works which will enable traffic to bypass Plaine Magnien Village.

In that context, the Road Development Authority has invited contractors to participate in an Open International Bidding (To Pre-qualified Bidders) for the project "Construction of a New Airport Access Road to SSR International Airport".

The estimated cost for the project is MUR 534,381,137.50 inclusive of 15% VAT. The corrected amount for the lowest responsive bidder is MUR 602,730,230.60 and is 12.8% more than the estimated cost. The corrected bid price is within the acceptable range of 15%.

## **13 Proposed Award of Contract**

Lowest evaluated responsive bidder proposed for contract award is **Bidder 3 Colas-GCC AML New Access Road JV** for the corrected amount of **MUR 602,730,230.60 (Rupees Six Hundred and Two Million Seven Hundred and Thirty Thousand Two Hundred and Thirty and Cents Sixty) inclusive of 15% VAT.**
