- b) Widening of existing road on both approaches of the new/rehabilitated bridge over an approximate length of 450m.
- c) Improvements works/tie-in on bridge approaches in an approximate length of 10 m both sides.
- d) Construction of road side footpaths, drains and retaining structures such as masonry walls;
- e) Diversion and relocation of existing services;
- f) Provision of miscellaneous road equipment such as road marking, cat's eyes, traffic signs, handrails, safety fences, road lighting etc...;
- g) Traffic flow shall at no time be interrupted during the execution of the works; and
- h) Any other works as detailed in the bid documents.
