

Executive Summary of Bid Evaluation Report

Upgrading of Road at Palmerston, Vacoas

CPB/49/2019

1. Scope of Contract:

The Sivananda Avenue and the Palmerston junction are already operating at full capacity, with heavy congestion during peak hours. With the implementation of the Metro Express Project, the Sivananda Avenue will be converted into a one-lane road and existing junctions at Vacoas and Palmerston will be signalized to synchronize metro and vehicular traffic. This will cause even more road congestion and lengthy waiting time for road users. Therefore, the Road Development Authority has decided to construct a new carriageway along the existing Sivananda Avenue and an Interchange at Palmerston junction to alleviate the congestion problem.

3. Date of Invitation of Bids

15 October 2019

4. Closing date for submission of bids

Bids were launched on 15 October 2019 with a closing date for submission set for 17th December 2019. However, prospective bidders requested the Public Body to consider extending the bid submission date since they planned to carry out traffic studies as from mid-January 2020, after resumption of school in order to obtain a more realistic picture of the traffic flow and constraints along the existing Sivananda Road.

Consequently, the closing date for the submission of bids was extended and rescheduled for Tuesday 04th February 2020.

5. Date and place of opening of bids

Public Opening of Technical offers was carried out on 04th February 2020 at 14.01 hours in the Conference Room at the CPB.

Public Opening of Financial offers was carried out on 28th May 2020 in the Conference Room at the CPB.
