#### 1. Scope of Works

- b) Widening of Ruisseau Marron Bridge and Riviere des Anguilles Bridge of approximate span of 12m and 14m respectively, including rehabilitation of existing bridge abutments, protection of existing piers, provision of footpath and bridge railings. The widening of Ruisseau Marron Bridge and Riviere des Anguilles Bridge shall be undertaken on a Design and Build basis by the Contractor;
- c) The upgrading and extension of existing pipe culverts and cross drains on P.J.G.G.N Road (B88);
- d) Construction of road side drains and retaining structures such as masonry walls;
- e) Diversion and relocation of existing services;
- f) Provision of miscellaneous road equipment such as road marking, cat's eyes, traffic signs, handrails, safety fences etc...;
