#### 1. Introduction

The purpose of this Expression of Interest is to request for proposals from **National Agencies** as single entity or in joint venture with other agencies to enter into an agreement with RDA to erect, maintain and fix indicative/directional signage on identical Totem Structure across the island (classified roads only) with a view to harmonise all signs.

Any agencies applying for shortlisting as consortium, association or any form of arrangement shall clearly indicate its status as a single entity or Joint as required in the submission.

#### 2. Objectives

The main objectives of the agreement are to jointly:

- a) Erect, display, control, operate, manage and maintain totems along the Classified Roads;
- b) Harmonise the totem structures
- c) Reduce the mushrooming of individual indicative & directional panels and private totems by regrouping the same on totem structures at strategic locations along the motorways and main roads;
- d) Contribute to the aesthetical view of the motorways and main roads infrastructure through high quality display of totems as compare to the existing ones;

#### 3. Responsibilities

Selected Agency will have the exclusive rights to design, procure/manufacture, erect, display, operate, manage, maintain, and market Totems along the motorways and main roads (classified roads) all over the island.

The Agency shall be responsible for the following main activities: -

- a) The Agency shall propose the exact locations where they intent to erect the totems, subject to the approval of the RDA;
- b) Design, commission and decommission the totem structures;
- c) Operate, manage and maintain the totems;
- d) For the Maintenance of the totems;

- The Agency shall be responsible for the cleanliness and good condition of the totem during the effective period;
- The Agency shall undertake periodic inspection to ensure that the Totems are adequately secured/braced, clean and safe; and
- Any broken plate shall be removed and replaced in due course.
- e) Management of sales & marketing to prospective subscribers;
- f) To seek and obtain all necessary approvals, authorisations, clearances, permits etc. from relevant Authorities at the Agency's own cost;
  In the event that totems are to be erected on private land, the Agency shall seek relevant written authorisation from landowner prior to placing the latter.
  Also, clearance from Central Electricity Board (CEB) is mandatory if any totem structures are located within 5 metres of high-tension cables.
- g) Fix a plate bearing a permit number in black with characters no less than 40 mm on each totem structure;
- h) Payment of all statutory taxes to relevant Authorities;
- i) The Agency shall inform the RDA of his intention to alter any approved locations or simply remove any totem structure at least thirty (30) days before doing so;
  - In the event that the selected locations of the Totems interfere with any existing Services/Utilities, the Agency to contact, liaise and obtain all clearance(s) from relevant Authorities; and
  - In the event that any existing Totems and individual directional panels have to be removed or relocated due to forthcoming Government's development, or otherwise, the Agency shall do so without any claim for compensation.
- j) The Agency shall be solely responsible for any civil or criminal litigation with or against hid clients/other Agency, any Authorities or the public in general regarding the type and contents of the Totems that are put up.

#### 4. Fees payable to RDA

The Agency will be provided with the exclusive rights to derive income or profit from his subscribers which will occupy the utilization of the spaces on the totems;

The Agency will have to pay a fixed fee for each totem to RDA at the end of every period of six months for this commercial exploitation irrespective of the income derived by the subscribers.

#### 5. Shortlisting Criteria

The evaluation of the applications for shortlisting will be based on the following criteria:

- (i) Aesthetic aspect of the proposed totem structure;
- (ii) Resources for the management of the structure in terms of general staffing, logistics and supports;
- (iii) Details of the proposed business plan;
- (iv) Maintenance Plan;
- (v) Innovations and
- (vi) Contribution to RDA roads (other than Financial).

Further to the evaluation of the Expression of Interest, the Request for Proposal (RFP) document for the project will be made available to **all shortlisted and qualified** Agencies.

#### 6. Duration of the agreement

The duration of the agreement with the agencies shall be for an initial period of thirty-six (36) months, renewable for another 12 months.

#### 7. Submission of Expression of Interest

The Road Development Authority now invites eligible and qualified agencies either solely or in joint venture to confirm their interest in providing the above services by filling in and submitting the Response Forms which are attached to this request.

Interested and qualified agencies may request for further information and clarification at the address below not later than 14 days before the submission date.
