Conflict of interests

RDA's Code of Ethics No.5 states that: "Employees should declare their interest when dealing with issues in which they have a personal interest".

Conflict of interests is one of the corruption offences as stipulated in the "The Prevention of Corruption Act 2002" (POCA).

The Act defines Conflict of Interest as follows:

Section 13. Conflict of interests


- (1) Where-
- (a) a public body in which a public official is a member, director or employee proposes to deal with a company, partnership or other undertaking in which that public official or a relative or associate of his has a direct or indirect interest; and
- (b) that public official and/or his relative or associate hold more than 10 per cent of the total issued share capital or of the total equity participation in such company, partnership or other undertaking,

that public official shall forthwith disclose, in writing, to that public body the nature of such interest.

- (2) Where a public official or a relative or associate of his has a personal interest in a decision which a public body is to take, that public official shall not vote or take part in any proceedings of that public body relating to such decision.
- (3) Any public official who contravenes subsection (1) or (2) shall commit an offence and shall, on conviction, be liable to penal servitude for a term not exceeding 10 years

Public Procurement Regulation no. 72 - Further identifies activities of the Public Body subject to conflict of interest restrictions as follows:

- (a) procurement planning, including preparation, review or approval of specifications, or a statement of work for a particular procurement;
- (b) assessment of requirements to be fulfilled by a procurement action;
- (c) preparation of procurement documents, including for solicitation of participation in procurement proceedings;
- (d) evaluation and comparison of bids, proposals, offers or quotations, including membership in bid evaluation committees;
- (e) conduct of technical discussions or negociations;
- (f) selection or approval of selection of bidder; and
- (g) administration of the procurement contract, including payments, and settlement of claims and disputes.



- the payment of the price provided for in a contract with a public body;
- obtaining for that person or for any other person, an advantage under a contract for work or procurement,

shall commit an offence and shall, on conviction, be liable to penal servitude for a term not exceeding 10 years.

- Any public official who solicits, accepts or obtains from any other person, for himself or for any other person, a gratification for giving assistance or using influence in -
 - (ci) promoting, executing, or procuring a contract with a public body for the performance of a work, the supply of a service, or the procurement of supplies;
 - the payment of the price provided for in a contract with a public body; (b)
 - obtaining for that person or for any other person, an advantage under a contract (c)

shall commit an offence and shall, on conviction, be liable to penal servitude for a term
