1. Project Details/Scope of Works:

The Scope of Works includes the following:

- Structural Rehabilitation/ Demolition of the existing structure and reconstruction of a reinforced concrete bridge approximately 15 m span and 12 m wide, on a design and build basis by the Contractor;
- Widening and resurfacing of existing road over an approximate length of 200 m.
- Construction of road side drains, footpaths and retaining structures such as masonry walls;
- Modification, protection and relocation of existing services such as telecom (MT), electricity supply (CEB), water supply (CWA), etc..;
- Provision of miscellaneous road equipment such as road marking, cat's eyes, traffic signs, handrails, safety fences, etc...;
- Provision of road lighting over an approximate length of 350 m;
- Landscaping works;
- Any other works as described in these document.
