# Section 1

# <u>Prequalification exercise to Participate in a Framework Agreement for Repairs</u> <u>and Maintenance of RDA's Vehicles</u>

#### **1.0 Introduction**

The Road Development Authority (RDA), operating under the Ministry of National Infrastructure and Community Development, is responsible for the design, construction, care, maintenance and improvement of classified roads. RDA has a fleet of vehicles and those vehicles must be serviced or repaired periodically or occasionally. RDA intends to enter into a framework agreement with potential workshops or garages.

The purpose of this prequalification exercise is to invite and shortlist eligible workshops or garages willing to provide services (repairs and maintenance) in mechanical, electrical or panel beating and painting of vehicles on an as and when required basis. The vehicles of RDA are posted in head office and sub offices located in different districts. To ensure proximity of service, the garages must be located in zones defined in table 1.

The types of vehicles available in RDA are Station Wagon Cars / Cars, Light Truck Vehicles, Double cabs 2X4, 4X4, SUVs and Tipper lorries.

#### 2.0 Eligibility Criteria of Garages/Workshops

The garages/workshop willing to form part in the framework agreement must satisfy the following criteria:

- i. The capacity to enter into a formal contract.
- ii. The appropriate license to operate (BRN, fire certificate, certificates complied with OSHA among others).
- iii. A secured compound/workplace to carry out the maintenance and repairs of the vehicles.
- iv. Trained mechanics, automobile electricians or painter depending on the services provided.Any person should have at least 3 years of experience.
- v. Essential tools and equipment to carry out either mechanical works or electrical works or painting and panel beating works.
- vi. Access to genuine or OEM spare parts.
- vii. The knowledge to use IT system.
- viii. Capacity to submit a performance security of Rs 25,000.

#### 3.0 Scope of Service

The workshop/garages must provide the following services:

- i. To carry out periodic maintenance of vehicles as per the manufacturer`s requirements.
- ii. To use spare parts of satisfactory quality, either original or OEM certified, and reasonably fit for any particular purpose that has been specified.
- iii. To carry out maintenance and repairs with reasonable care and skill and within a reasonable time and to maintain RDA's vehicles in a road worthy condition under the Road Traffic Act and any existing traffic rules and regulations in force in Mauritius.
- iv. With regards to other additional works that must be done after inspection during the periodic maintenance or repairs of any vehicle, the garage/workshop will be requested to give a detailed report/quote for the repairs.
- v. Concerning any major or breakdown mechanical or electrical repairs or works involving panel beating and painting in any vehicle where the garage/workshop has to make an assessment, a quote that contain the breakdown of works including labour cost and the type of spare parts required must be given to RDA's representative.

#### **4.0 Duration of the Service**

The framework agreement will be for a period of 12 months.

#### 5.0 Procurement Process for the Selection of the Applicant for this Service

This request for prequalification exercise is for the shortlisting qualified applicants who are interested to provide services in mechanical or electrical repairs or works involving panel beating and painting in vehicles for a duration of 12 months.

The closing date for submission of the prequalification document is 22 November 2023 at 13:30.

# **Terms of Reference**

RDA is engaging in a prequalification exercise in view of identifying eligible garages/workshop/company/enterprise which are specialized in at least one of the following: **mechanical repairs and maintenance, electrical repairs, panel beating and painting of motor vehicles.** Those garages/workshops are required to submit bids through a procurement exercise for:

#### A. Mechanical Repairs and Maintenance

- To quote for periodic maintenance of vehicles including for spare parts to be used
- To quote for mechanical repairs which occurs frequently (example in suspensions and transmissions, among others) including spare parts to be used
- To quote for labour rate per hour for major repairs of vehicles
- To supply spare parts if same is below Rs 10,000 provided that the price is fair and reasonable and same has been controlled by RDA officers

#### **B. Electrical Repairs**

- To quote for labour rate per hour for major repairs
- To supply spare parts if same is below Rs 10,000 provided that the price is fair and reasonable and same has been controlled by RDA officers

#### C. Panel Beating and Painting Repairs

- To quote for labour rate per hour for major repairs
- To supply spare parts if same is below Rs 10,000 provided that the price is fair and reasonable and same has been controlled by RDA officers

For any repairs above Rs 10,000, spare parts will be provided by RDA using its procurement procedures in a short amount of time.
