  - i. Business Registration Number;
  - ii. Valid Trade Licence; and
  - iii. A photocopy of ID Card of owner/approved representative.
- 5. Bidders should quote on price per ton of scrapped metals basis inclusive of all relevant charges, viz, transport, labour, weighting etc. The Bidder, its affiliates or subsidiaries shall submit only one proposal and shall confirm same. If a bidder submits or participates in more than one proposal in this bidding process, such proposals shall be disqualified for the same item.
- 6. Bidders should undertake to effect a down payment of 30% of the total value of their offer upon award of contract, if successful prior to taking the delivery. All scrapped metal sold should be taken away within a period of one month using bidder's own means of transport, labour etc. following letter of award. An officer from the Road Development Authority will be present to confirm weightage. Other terms and conditions will apply.
