The **Road Development Authority** is inviting bids from eligible bidders of Mauritian nationals or entities incorporated in Mauritius/opened to local bidders through the Government eProcurement System for the **UPKEEPING AND ASSOCIATED MINOR ROUTINE WORKS ALONG CLASSIFIED ROADS (2024-2025)**. Participation is limited to citizens of Mauritius or entities incorporated in Mauritius. Joint ventures should be among entities incorporated in Mauritius.

3. Bids must be submitted online on the eProcurement System at latest by **29th July 2024 up to 13:30 hours (Mauritian Time)**.
4. Bidders who have submitted bids online by the closing date and time shall decrypt and re-encrypt their bids from **29th July 2024 as from 14:31 hours (Mauritian Time) till 31st July 2024 at 14:00 hours (Mauritian Time)**.
5. Interested bidders should register by signing up on the e-Procurement System of the Government of Mauritius on <http://eproc.publicprocurement.govmu.org> in order to participate in the bidding exercise.
