The **Road Development Authority** is inviting bids from eligible bidders of Mauritian nationals or entities incorporated in Mauritius/opened to local bidders through the Government eProcurement System for the **Rehabilitation of Footbridge at Venus along A1 Road**. Participation is limited to citizens of Mauritius or entities incorporated in Mauritius. Joint ventures should be among entities incorporated in Mauritius.

3. Bids must be submitted online on the eProcurement System at latest by **05 August 2024 up to 13.30 hrs. (Mauritian Time)**.
4. Bidders who have submitted bids online by the closing date and time shall decrypt and re-encrypt their bids from **05 August 2024 as from 14:31 hours (Mauritian Time) till 07 August 2024 at 14:00 hours (Mauritian Time)**.

Interested bidders should register by signing up on the e-Procurement System of the Government of Mauritius on <http://eproc.publicprocurement.govmu.org> in order to participate in the bidding exercise.
